Conditions for safe storage, including any incompatibilities

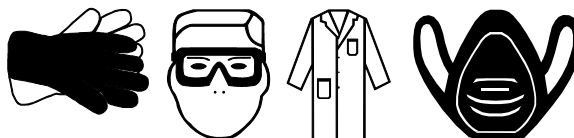
